 - 1. They see an incident and report directly to admin if it is warranted (serious incident or accident)
 - ii. Second line of notification is the student to a teacher or supervisor
 - 1. This can be problematic as many are unwilling to say something
 - a. We are continuing to push this and will be a topic of our next assembly
 - 2. If a child is injured or appears to be in distress, cameras are now in place and are checked when a supervisor suspects something has happened but the student is unwilling to say anything
 - iii. Third line of notification is student to a parent
 - 1. When this happens please contact the school ASAP so that incidents can be rectified in a timely manner
 - Also, speak to your child about the importance of talking to an adult at the school when something happens – don't take "they don't listen" for an answer – they can always come to Mr. Munch
 - iv. Current supervision:
 - 1. In a typical week, there are 30 blocks of 15-20 minutes of supervision.
 - 2. The teaching and admin staff do 8 each with support staff providing 6 (2 x 3).
 - 3. Our PUF EA supervises her PUF students
 - 4. We would love to have more supervisors but with limited staff it really isn't feasible without a significant increase in workload.
